**The below terms and conditions of the Men of League Foundation membership are relevant to the purchase of a 2018 membership. By ordering a membership you expressly agree to be bound by and comply with these terms and all applicable laws and regulations. These terms and conditions of membership are subject to change and are at the discretion of the Foundation.**

## Purchase of membership

If you are successful in your application for membership, the Foundation will send you an email confirmation. If we do not have your email address and you would like confirmation, please provide an email address to us by contacting the membership team at [membership@menofleague.com](mailto:membership@menofleague.com)

The Foundation will not process any form which is incomplete or accept any changes to the form (except for a change of mailing address). The Foundation reserves the right to not accept any form in its absolute discretion.

Membership is available on a seasonal basis, and is valid from February (or date of purchase) until the 31st of January.

## Change of address

Members who do not advise the Foundation of a change of address will be charged an additional \$15 if a replacement membership pack is required or \$5 if a replacement card is required.

## Delivery of welcome packs

Member packs will commence lodgement in March 2018 and will arrive within 6 weeks of the purchase of membership.

## Membership enquiries

## Cancellations, refunds and replacements

Refunds are not available on memberships purchased from the Foundation. The content of the membership forms is correct at the time of printing and the Foundation is not responsible for any omissions, errors or changes that occur.

The Foundation reserves the right to cancel membership at any time if, in the Foundation's opinion, a member engages in behaviour which is deemed prejudicial to the interests or reputation of the Foundation.

## Membership emails

The Foundation sends regular emails to members with updates on membership, wellbeing initiatives and local event information. If you haven't registered your email address with the Foundation, you can update your member profile on the Men of League Foundation website using your username and password, or contact the membership team.

## Payment plan

The Foundation's payment plan enables members to automatically renew membership from year to year. All members are automatically placed on the payment plan if a credit card or bank account is used for membership purchase. The same package will be renewed automatically from the credit card or bank account provided previously unless you indicate that you would like to opt out of the plan or change your package.

The Foundation will contact you one month prior to the annual payment as a reminder as well as to notify of any fee increases. If you wish to change your package, opt out of the program or change your payment details, you will need to notify the Foundation of this in writing within one month of the notice. If you do not notify the Foundation of any changes, you have agreed for your membership to roll over.

It is the responsibility of each member to ensure that the account details provided are correct and that sufficient clear funds are available in the nominated account on the scheduled payment date.

If the debit is returned or dishonoured by your financial institution, the Men of League Foundation will contact you to request immediate payment. Any fees charged to you by your financial institution will be payable by you. If the payment declines, the membership will be considered lapsed until a successful payment is made.

## Members privacy
